DOs

- Treat official matters as your own and handle the same with prudence and care you apply in your personal matters.

- Be honest, upright, fair, but firm.
- Show unfailing courtesy to people in all matters. Keep your personal views to your self and discharge your duties as expected of the office held by you.
- Promptness is the very heart of vigilance. Delays cost are much more than what we assume. Such losses are not only financial but human, technology and opportunity losses.
- Every one is a vigilance officer. Every H.O.D / Manager is responsible for the probity of his officers and cleanliness of transactions handled by them.
 We should measure the integrity quotient of a person with the same enthusiasm as we measure one's intellectual quotient.
- Respect the law, Protect the law, Defend the law. It protects and defends you in need.
- "Ignorance of Law is no excuse" is a popular saying in legal studies. The same is true in vigilance too. Strengthen your knowledge on vigilance related rules and regulations. You would then be safe.
- Constant integrated awareness is required for an Executive. Develop this attitude. You will then be sound in your approach to all issues and matters concerning your official work.
- Documentary support is vital for vigilance decision.
- Leverage Information Technology in discharge of your vigilance functions.
- Sky is the limit to creativity and innovation. Suggest new ideas and win laurels.
- Vigilance earns respect for the Company from public, customers, media and Government.

DON'Ts

- Don't be biased or prejudiced in decision making. Objectivity is the key for effective vigilance.
- Do not have unwarranted or undesirable relation with the outsiders with whom you have to be in official terms.
- Never use your official position for personal gain directly or indirectly.
 Don't mix them up.
- Never be negligent in completion of basic details in official transactions.
- While spending official money, never be extravagant.
- Treat one rupee of public money as equivalent to a hundred rupees of your own.
- Never do any thing that is morally indefensible and contrary to law.
- Vigilance is not merely mechanical compliance with documentation. Put your heart, soul and mind into it.
- Never justify wrong means for attaining what is considered a right end. Means must justify ends. This is the "eternal Law of vigilance".
- Never fail to see the big picture. Never neglect the interconnectedness of your actions and its impact on the organisation.
- Never adopt back door method for getting anything done. It will not last. It may put you in trouble too.
- Never violate the principle of consistency in word, thought and deed in all
 official matters. This should also be in harmony with what is correct and
 proper.
